Please find below a summary of the 14 October POCA Board meeting conference call. The call lasted 1H 40M. In attendance were all Board members except Ed Mendez / advertising.

Treasurer's Report - Rob D'Orazio

- Checking balance \$24,046, up about \$3934
- Checking + Savings balance \$42,687

Membership - Josette D'Orazio

- 897 Members
- New memberships are largely offsetting lost members
- Out of compliance chapters
 - New Jersey a former chapter member has conversed with Scott Martin concerning reactivating the chapter. He will contact the members to understand the member interest in reactivating the chapter. If there is insufficient interest, the chapter will be assimilated by another eastern POCA chapter
- Membership Director Position
 - One person has expressed interest to Josette. That unnamed person does not want to be on the election ballot as she will help with the membership director's position only if no one else steps-up
- Electronic Membership renewal
 - Discussed moving towards 100% electronic membership renewal
 - Josette indicated there are still some people that are challenged by electronic renewal and need over the phone coaching
 - Some people will not do electronic renewal so the thought is to send those people a mail reminder once they are 2 weeks delinquent

Matt Stone Historic Material Purchase

- POCA has purchased the Matt Stone collection
- The collection is currently in Mike Drew's position.
- The D'Orazios when on vacation in northern California will pick-up the collection Mike Drew and take it to Scott Mead for digitizing.

• Still need to decide what to do with physical collection once digitized. Also need to decide how to use the digitized materials.

New Board Positions

- Scott Martin brought up the idea of adding new voting board positions
- Those positions could be for club store (produces a income stream for POCA), archives, historian, registry
- If positions are added via a change in the bylaws, the total number of board members should remain an odd number

De Tomaso Registry

- Considerable discussion on the creation of a De Tomaso registry
- It was noted there are other De Tomaso registries already in existence run by George Pence and Chuck Melton and if there was a possibility to acquire those or form a relationship with those persons
- There was also discussion concerning why PI (Pantera International) exists and why POCA and PI have not merged
- No one knew the history but presumed there was bad blood in the past, or maybe still is
- One of the board members will be seeing a registry owner soon and make some inquiries
- There was discussion about talking to long time POCA members that would know the PI / POCA back story to better understand the history before approaching PI regarding a relationship

De Tomaso Logo Rights

- POCA has received a letter from De Tomaso Automobili CEO (P72 project company) the owner of the "classic" logo and the P72 "stylized" logo rights authorizing POCA to use the "classic" logo
